

They however did make a mistake in that stating there is a CD available in the printed edition but you can go to the publishers website and download the excel model. If you have a US computer you will need to run a macro contained in the file to switch from Italian to US (dont know technically why but it does clean it up a bit and removes the #num errors). Besides that issue, its a good book and I recommend it. Its not expensive either. I consider it my favorite PF book.

The whole point of buying this book is to learn about the modeling aspects of project finance, without the excel models, it is like learning to play piano by watching youtube. I will not consider buying any kindle version textbook until has a solution to this.
